Educate Girls awards grants to proximate non-profit partners in India to engage in programmatic activities in support of the mission to ensure that girls are in school and learning well. In the past year, grants were awarded to local non-profit partners working in multiple states, including Rajasthan, Madhya Pradesh, Uttar Pradesh, Haryana, and Bihar. The Educate Girls investment includes multi-year grant awards as a long-term commitment and investment in the villages in which our partners work and acknowledges the commitment to girls' education as an ongoing responsibility to each girl once we make an investment in the village. Programs supported were focused on identification of out-of-school girls, enrollment, retention, and learning outcomes of vulnerable girls from remote villages into government schools for primary through secondary education.

Educate Girls invests in technical advising and capacity building of grantee partners in the areas of data analytics, performance management systems, strategy, and program management software. Our partners use the performance management systems to enhance their ability to collect and track data, resulting in improved data collection and robust metrics. These investments are central to the Educate Girls' core philosophy of engaging in proximate grantmaking in order to build and strengthen the ability of local non-profit organizations to deliver the Educate Girls model in their districts while ensuring effectiveness, efficiency, and sustainability.

Educate Girls invests in global strategic engagement to amplify the issue of girls' education and provide thought leadership to share our impact, promote locally-based and outcomes-driven grantmaking, and participate in conferences with global leaders. Pt III, Line 3: The Organization has put plans in place to utilize its restricted net assets with multi-year grant awards to grantee partners as a longer-term investment in a village in order to ensure that girls are supported throughout their educational journeys. Educate Girls' grantmaking has expanded with partners in the states of Bihar and Rajasthan and has added 10 new grantees for a total of 26 grantees in the portfolio. A significant majority of the funds are fully committed to program expenditure for the final year of the Audacious Project, Program Vidya, and Pragati. These projects aim to enroll approximately 1,560,000 girls into school in rural communities in India, improve learning outcomes for 950,000 children, and ensure a responsible exit strategy for our partner program villages (operationalized in the past 3-5 years), including ongoing enrollment and learning support for children. The new ten-year strategic plan includes an ambitious goal of impacting 10 million learners over the next 10 years in rural geographies with some of the most vulnerable and marginalized girls. The plan includes delivery models: through local community-based organizations and, by leveraging partnerships while unlocking resources.
