Educate Girls awards grants to proximate non-profit partners in India to engage in programmatic activities in support of the mission to ensure that girls are in school and learning well. In the past year, grants were awarded to local non-profit partners working in multiple states, including Rajasthan, Madhya Pradesh, Uttar Pradesh, Haryana, and Bihar. The Educate Girls investment includes multi-year grant awards as a long-term commitment and investment in the villages in which our partners work and acknowledges the commitment to girls' education as an ongoing responsibility to each girl once we make an investment in the village. Programs supported were focused on identification of out-of-school girls, enrollment, retention, and learning outcomes of vulnerable girls and also a second chance

Educate Girls invests in technical advising and capacity building of grantee partners in the areas of data analytics, performance management systems, strategy, and program management software. Our partners use the performance management systems to enhance their ability to collect and track data, resulting in improved data collection and robust metrics. These investments are central to the Educate Girls' core philosophy of engaging in proximate grant-making in order to build and strengthen the ability of local non-profit organizations to deliver the Educate Girls model in their districts while ensuring effectiveness, efficiency, and sustainability.

Educate Girls' grantmaking has expanded with partners in the states of Bihar, Rajasthan, Haryana and Madhya Pradesh and has added 8 new grantees for a total of 23 grantees in the portfolio. A significant majority of the funds are fully committed to program expenditure of Program Vidya, and Pragati. These projects aim to enroll girls into school in rural communities in India, improve learning outcomes for children, and ensure a responsible exit strategy for our partner program villages (operationalized in the past 3-5 years), including ongoing enrollment and learning support for children. The new ten-year strategic plan includes an ambitious goal of impacting 10 million learners over the next 10 years in rural geographies with some of the most vulnerable and marginalized girls.
